



# Saint Louis County Department of Public Health Monthly COVID-19 in Long-Term Care Facilities Report

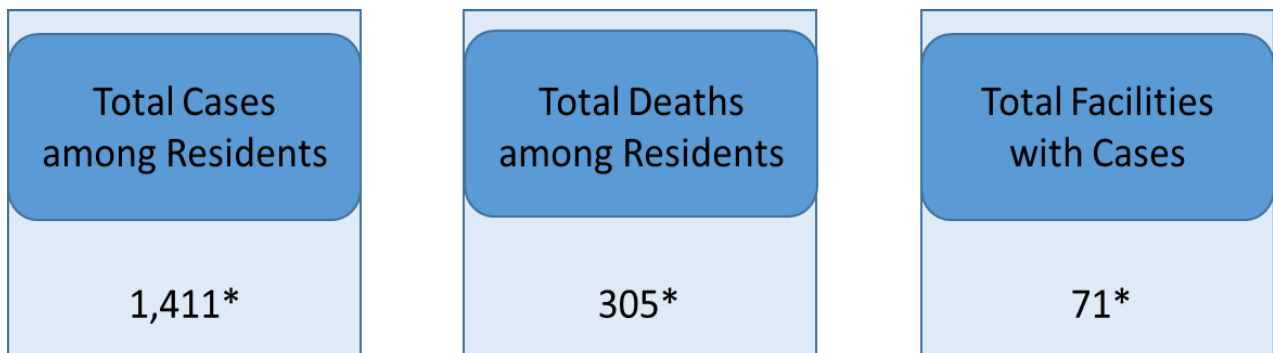
COVID-19 has had a disproportionate impact on residents of long-term care facilities. The Saint Louis County Department of Public Health (DPH) is sharing information regarding said cases in an effort to help the public better understand the impact of COVID-19 in our community.

The data below describes the impacts of COVID-19 on residents of Long Term Care Facilities in St. Louis county licensed by the Missouri Department of Health and Senior Services, Section for Long-Term Care Regulation which include Skilled Nursing Facilities (SNF); Intermediate Care Facilities (ICF); Assisted Living Facilities (ALF); Residential Care Facilities (RCF). Data is based on information self reported to DPH as of Wednesday, June 3<sup>rd</sup>, 2020. Numbers will be adjusted as more information is received. Note that in facilities where there are five or fewer cases, the exact case count is not given to help protect the identity of affected individuals.

DPH works hand-in-hand with facilities to ensure aggressive mitigation measures are in place, assist in personal protective equipment is stocked, and testing is readily available. This vital work is done in coordination with the State Section for Long Term Care Regulations, who license these facilities, and the St. Louis County High Risk Task Force. The existence of cases in facilities should not be interpreted as an indictment of the care residents receive — close quarters and the age/chronic health conditions of many residents have made long-term care facilities vulnerable to outbreaks.
